General Information

Following the success of the last Seminar on Environmental Auditing in April 2014 in Hanoi, Vietnam, the National Audit Office of P.R.China, in the capacity of the Chair of ASOSAI WGEA, will organize the 6th Seminar on Environmental Auditing and 5th Working Meeting on 17-19 October 2016 at International Centre for Environment Audit and Sustainable Development (iCED), in Jaipur, Rajasthan India, with the administrative support of the Office of the Comptroller and Auditor General of India (CAG). It goes without saying that this seminar will be a great opportunity for ASOSAI members to share experiences and best practices on environmental auditing.

Jaipur-A brief glance

Jaipur is the capital and the largest city of the Indian state of Rajasthan in Northern India. The city has a population of more than 3 million, making it the tenth most populous city in India. Jaipur is known as the Pink City of India. Located at a distance of 260km from the Indian capital New Delhi, it forms a part of the Golden Triangle tourist circuit along with Agra.

How to reach Jaipur:

By Air:

Air travel to Jaipur is the most convenient way to reach the city. Airport is located in the southern suburb of Sanganer, which is 13 km (8.1 mile) from the heart of the city / 47 Km (29 mile) from iCED. It has both international and domestic terminal and is well connected to most of the cities across the country and a few aviation hubs in the Middle East. Popular carriers like Air India, Jet Airways, IndiGo, Oman Air, SpiceJet, Air Asia have daily flights to Jaipur from metro cities of India viz. Delhi, Kolkata, Chennai, Mumbai, Pune and Bangalore. Flights also connect Abu Dhabi, Dubai, Muscat, and Sharjah to this airport. Direct flight to Singapore will start from 3rd October, 2016.

Other modes of travel from Delhi:

Train:

It takes 4.5 to 6 hours to reach Jaipur from Delhi by train. There are several trains which connect Jaipur to Delhi. Jaipur Junction is located 39 Km from iCED.

Road:**Private Taxi:**

iCED campus is 215 Km from Terminal-3 of International Airport of Delhi and can be reached by taxi in 3.5 to 4 hours.

Bus:

Volvo bus service between Jaipur and Delhi operated by Rajasthan State Road Transport Corporation (RSRTC) with buses every hour to and from both sides. From Delhi one can board the bus from Bikaner House on Pandara Road which is next to India Gate 15 Km (9 miles) north of Terminal-3 of International Airport of Delhi. One can get down at Amity University / Achrol on National Highway 11C which is 3 / 5 Km from iCED.

Logistics

Obtaining valid visa to India is the responsibility of SAIs/ participants. An official invitation letter shall be sent to every participant (if necessary) for the convenience of applying Indian visa.

SAI India will provide pickup from / drop at Jaipur International Airport to / from iCED and also organize domestic transportation for the activities outside the venue. International traveling expenses, medical insurance and accommodation costs of participants shall be borne by relevant ASOSAI WGEA members. On this occasion, SAI India would like to offer a food and lodging package at a composite charge of US\$ 125 per person for the whole seminar period.
