International Centre for Environment Audit & Sustainable Development (iCED) organized a 05 days' National Training Programme on "Blue Economy: Blue Economy with special focus on Marine Tourism and Audit of SDG-14 and related SDGs (Terrestrial & Aquatic)", from 21.08.2023 to 25.08.2023 at its own campus. A total of 20 participants from 07 field offices including 07 group officers, participated in the training programme.

Ms Sayantani Jafa, Additional Deputy Comptroller and Auditor General & Director General, iCED inaugurated the training programme. She welcomed all the participants. ADAI Madam emphasized the importance of the National Training Programme on "Blue Economy: Blue Economy with special focus on Marine Tourism and Audit of SDG-14 and related SDGs (Terrestrial & Aquatic)" and its role in raising awareness and providing knowledge about the Blue Economy, particularly its significance for the sustainable development of coastal regions and India as a whole.

She further emphasized that the blue economy is a complex concept encompassing economic activities related to oceans and coastal areas, gaining global attention for its potential in economic growth and sustainability. India, with its extensive coastline and coastal population, sees the blue economy as crucial for its economic expansion. It aligns with sustainable

development goals, particularly Goal 14, labelled "Life below Water", which focuses on conserving oceans and marine resources through international cooperation.

The success of marine tourism reflects India's commitment to balancing prosperity and environmental preservation.

ADAI Madam added that the Hon'ble C&AG of India, as the Chair of the SAI-20 organisation, has highlighted the importance of audit of multifarious sectors of the Blue Economy and in recognition of the same, designated iCED as the Centre of Excellence for Audit of Blue Economy.

She highlighted iCED's commitment to capacity building efforts, having trained participants from over 25 countries in

the past three months, including around 70 participants from SAI India, on different dimensions of the Blue Economy. This reaffirms iCED's role as a hub for research, experience sharing and knowledge dissemination in Blue Economy Audit.

Further, she also briefed about outdoor activities like Shopping excursion to Bapu Bazar, the traditional market of Jaipur and Sports and other facilities at iCED Campus etc.

With this introduction, Ms. Jafa again warmly welcomed all the participants to iCED, expressing hope for a productive and engaging training programme and a pleasant stay on the campus.

During this five days' training programme, 09 experts from various organizations such as The Energy and Resources Institute (TERI); Annamalai University, Tamil Nadu; National Maritime Foundation (NMF); National Centre for Coastal Research (NCCR); Director General of Shipping; Indian National Center for Ocean Information Services (INCOIS) and IA&AS Officers from IA&AD were invited to deliver the sessions on various aspects of Marine Tourism and Audit of SDG-14 and related SDGs.

This advice, she noted, is particularly relevant when approaching audits in the multifaceted landscape of the Blue Economy.
